The annual meeting for the Arbors Improvement Association will be held on August 26, 2006. This year we will use the Fellowship Hall at the 1<sup>st</sup> United Methodist Church in Elgin. If you are a new resident in the Arbors, on behalf of the Board, I welcome you as a neighbor and encourage you to make plans to attend this Annual Meeting where you can meet other Arbors residents and get to know how our Association works.

If you are a long time resident of this community, then you already know the importance of attending this annual meeting... the only meeting actually required by the Arbors Improvement Association Bylaws.

In this, the last newsletter before our annual meeting, I would like to focus on volunteerism in our community and how vitally important it is that you consider getting involved in an Arbors committee. There are five standing committees: Architectural Control, Maintenance & Safety, Arbors Angles Newsletter, Community Awareness, and Welcome & Social activities. Each and every one of these committees is comprised of people just like you. They may be retired or may have full time jobs, but they volunteer what time they can and are always very generous with their labor when called on to help with community projects.

The committee volunteers are one big reason our homeowner dues have not increased since the Arbors was incorporated! That says a lot about the incredible contribution our committee members have made to this community.

Your homeowner dues support all the functions and activities involved in keeping our community alive, vibrant and growing: from the cost of street lights and other utilities, to Park cleanup; from mowing and gate maintenance, to easement repairs. And of course, your dues also pay common area property taxes and community liability insurance. So...you pay dues, why not get your money's worth and become involved with how your dues are spent? I am sure you will be impressed by all the hard work Arbors resident volunteers do in order to make each activity a success.

One final comment about our community: the Arbors is a private subdivision and one that was established under a set of rules called the CC&R's or the Conditions, Covenants and Regulations. These rules, often called deed restrictions, were set forth by Sabine Investments when that company developed the property we all know as the Arbors at Dogwood Creek. As buyers, we all signed the CC&R's when we closed on our homes and properties, agreeing with our signatures to follow these community rules. You have a copy of them in that stack of documents you received from the title company when you closed on your home. (A copy of the CC&R's can also be printed off the Arbors web site, which address is prominently displayed elsewhere in this Newsletter.)

So many papers, so much reading! But please, do acquaint yourself with the contents of this document... it's very important information because it has a direct impact on the value of one of the most important investments you will ever make: your home!
