## **Arbors Annual Dues**

It has been brought to the AIA Board's attention from a number of property owners that they have not received an invoice for their 2009 annual Arbors maintenance dues. Every property owner is required to pay their assessed dues by the end of January of each year. If the assessment is not paid within thirty (30) days of the due date, the assessment shall bear interest from the date due at a rate of eighteen per cent (18%) per annum.

# **Road Work In the Arbors**

The Board has contracted with Integrity Asphalt to repair the road cracks in the Arbors roadways. With the dry spring, summer and fall, more surface cracks were formed on our 10 year-old roads. One of the major causes of such cracks (other than use) is the drying of the ground under the road base. We identified over 50 specific areas in need of repair throughout the Arbors with some being very minimal to some being fairly deep and wide (mainly on Juniper Trail). Integrity Asphalt has reviewed the areas with us and will use a state-of-the-art polymer material that flows into the cracks that remains pliable when dry. This will keep any water from entering the cracks and causing additional damage to the road surface. This material may be driven over about 10 minutes after application, so no roads will be closed when the crew is here doing the work.

# Format Change for Newsletter Proposed

The subject of the Arbors newsletter moving from hardcopy print to online viewing has been raised several times over the last few years and was raised again at the 2008 annual meeting. The Board wants to provide as much information as possible to Arbors owners through use of all available mediums and considering converting is the newsletter from a printed format to an online format. We are asking for the input of the community. The goal is to reduce or eliminate the newsletter expense. We budgeted a total of \$3,500 for postage and mailing for 2008, of which a good portion goes for printing and mailing the newsletter.

Creating and producing a hardcopy newsletter has its limitations. We are careful to keep the newsletter to a certain number of pages due to cost considerations and only allow color photos of events from time to time, once again due to cost. Printing and mailing the newsletter three or four times each year creates an expense to the AIA.

Researching alternatives opened the possibility of placing the newsletter online. Removing the printing from the newsletter process reduces the amount of time required to produce the newsletter, and removes the management company from the process, as they handle printing and mailing the newsletter for the Moving the newsletter Arbors. online also allows different software to be used which is easy to post to the website and expands the items that can be included in the newsletter without adding any additional costs. Anyone with internet access can view the newsletter once posted on (no need for an email address) although we may elect to send an email notice that the newsletter is ready for viewing, if we move toward an online newsletter.

Converting the newsletter to online viewing versus hardcopy print seems to be an all or nothing situation. We've discussed offering both methods and asking owners which method of delivery they prefer, but when we reduce the number of printed copies we produce, the price increases, as well as the hassle factor of keeping up with which owners prefer which method.

So, please provide your input. We are asking owners to email your thoughts on moving the newsletter to an online format. The email address is <u>nl\_response@arborsia.org</u>. This address is just for newsletter input and will not produce a response. We thank you for your time.

This \$200 million facility, located on the old Robt. Muller Airport site, is a modern marvel. Officially known as The Dell Children's Medical Center of Central Texas, it is a member of the Seton Family of Hospitals, and serving a 46-county area, it is the only dedicated freestanding pediatric facility in the region.

This facility is also the first hospital in the world to receive the LEED (Leadership in Energy & Environmental Design) Platinum designation, awarded by the U.S. Green Building Council. When one steps inside, it is apparent why such an award was given to this location: it boasts an environment that is at once professional and welcoming, while offering features such as natural light and pollutant-free, fresh air and six inner courtyards. It is the kind of facility that everyone hopes will never be a necessity for their family, but one that is valued beyond price if the situation does warrant its use.

We have also made plans with L&M Landscape to begin adding road base along the road surfaces where the original base has eroded away from the shoulder of the roads The material that will be used is a oneinch limestone road base material that is locally available and used specifically for the public roads in Once compacted, this the area. material becomes very solid and is less likely to wash away. This will be an ongoing project in order to protect the asphalt from breaking away from the edge of the roads.

As you are aware, the original roads in the Arbors are about 10 years old and have seen both construction and normal traffic activity. We have been fortunate that the original developer hired a quality contractor to build the road beds and surface the roads with highway-strength asphalt. These are the first repairs that have been made specifically to the roadways (Note: right-of –way erosion repairs have been made and are related to keeping the road base in place).

With this type of preventative maintenance, it is our goal to delay any major capital expenditures, such as resurfacing areas of the roadway, until such time as absolutely necessary.



# **Highway 95:Accident Prone**

Most, if not all residents of the Arbors have seen or been caught in the traffic tie ups that occur as a result of a traffic accident on Highway 95.

Though not in the normal purview of a Homeowners Association, AIA Board members have contacted TxDOT in the past to voice concerns regarding the number (and severity) of accidents that occur on this stretch of road between Elgin and Bastrop.

In addition, the Board has tried to get some measure of protection for drivers turning left into the Arbors by requesting the addition of a dedicated left turn lane and/or signs warning drivers of turning traffic.

Unfortunately, these efforts have not met with much success. Though we have seen "some" increase in police presence on Hwy 95, the number of accidents has not lessened. And a dedicated left turn is not feasible according to TxDOT, due to lack of road width available for an additional lane.

Privacy laws prevent obtaining specific information regarding the number of accidents and the fatalities, if any that occur with each traffic incident. To obtain a specific crash report, TxDOT requires two of three pieces of information: date, precise location, or the name of at least one person involved in the accident. Not many of us can offer latitude & longitude or the names of persons involved in any particular incident, so reliable statistics are difficult to acquire. In the past, one could count the roadside crosses placed on the ROW in memoriam to someone who had died in an accident at that location. As little as three years ago, there were 16 crosses on the Highway 95 ROW between Bastrop and Elgin. That is one fatality per mile of roadway.

Since then, some of the crosses have mowed over or taken down. But new ones are added as more people are involved in fatal accidents along this stretch of road.

The AIA has asked the Homeowner's Association of Cedar Hills to join with us in a effort to highlight this issue with TxDOT, to make Highway 95 a safer road for us all. The AIA Board encourages residents to write, call or email their concerns to the following:
